## What's New

### Virtua Server

The following table details the new features and functionality included in this release.

ID	NetSuite	New Feature Release Note
VIRTUA-24756	1028775	In previous versions, Virtua required you to install operating system library files from older, unsupported operating systems. As of 16.4 SP2, Virtua no longer requires these older operating system library files when using Red Hat Enterprise Linux 7, Red Hat Enterprise Linux 8, CentOS 7, or CentOS 8.

The following table details the fixed issues for this release.

VIRTUA-24859, VIRTUA-24798, VIRTUA-24799	1064763	<p>Problems sometimes occurred when you used the <b>Uncheck-In</b> button to undo a bulk serials check-in and later checked the same issues in again. If one or more of the items was already assigned to a shipment box, checking the issue in again removed the link between the item record and the purchase order. This prevented you from updating the Box ID or Shipment ID.</p> <p>Virtua now displays a warning message when you select the <b>Uncheck-In</b> button for a received issue that is not assigned to a shipment box. The message prompts you to manually update the 863 or 866 tag. The message also lists the items that were created for the issue at check-in and prompts you to delete those items. An <b>Export CSV</b> button appears, which allows users to export the list of item IDs that must be manually deleted due to the uncheck-in process.</p> <p>In addition, Virtua now displays a message and prevents you from undoing a check-in if any of the associated items are already assigned to a shipment box. The message lists the name of the shipment box and the item IDs of the associated items. An <b>Export CSV</b> button appears, which allows users to export and save the list of item IDs and the box IDs.</p>

VIRTUA-24800	1064763	<p>To support the improved serials uncheck-in workflow described above, a new option allows users to open the item record associated with a received issue by right-clicking on the <b>Received</b> tab of the Serials Bulk Check-in window and selecting <b>Link to item</b>.</p> <p>If the item record was previously deleted, Virtua displays the warning message: "Warning: No records found."</p>
VIRTUA-24871	1122881	<p>Virtua previously allowed users to insert an item into a box even when the item was part of a canceled PO. This is fixed. Virtua now displays an error message and prevents users from inserting items from a canceled PO into a box.</p>
